

HAZER INTELLECTUAL PROPERTY UPDATE

- **Hazer’s Australian patent application AU 2016240393 is now accepted**
- **Hazer’s innovation patents (AU 2018101788 and AU 2018101787) are both now granted**

PERTH, AUSTRALIA; 17 DECEMBER 2018: Hazer Group Ltd (“Hazer” or “the Company”) (ASX:HZR, HZRO) is pleased to announce that it has been advised of the acceptance of one of its Australian patent applications and grant of two patents covering various aspects of the Hazer Process. Details of the respective acceptance and award of patents is provided below.

Hazer is pursuing a structured and rigorous intellectual property (“IP”) protection program through a series of Australian and international patent applications through four patent application families under international patent treaty and national jurisdiction rules. Remaining patent applications remain ongoing and continue to be pursued as per the normal procedures of the various patent organisations.

Hazer is pleased to announce that its Australian patent application entitled “A process for producing hydrogen and graphitic carbon from hydrocarbons” has been accepted by the Australian patent office.

The application will now enter the mandated opposition period. After the expiration of the opposition period, the Deed of Letters Patent will be issued three months from the date of advertisement.

Hazer is also pleased to announce that two innovation patents have now been granted. Each of these patents are entitled: “A process for producing hydrogen and graphitic carbon from hydrocarbons”.

As set out in our announcement dated 23 November 2018 entitled: “Hazer Intellectual Property Update”, these patents will now be certified. The innovation patents, once certified, will broaden Hazer’s future licensing pathways and provide additional protection to preserve our rights with regards to the Hazer Process.

Hazer’s Chief Executive Officer, Geoff Ward, states “We are extremely pleased to have received the award of these innovation patents and acceptance of our first Australian patent. We will continue to pursue our remaining patent applications as part of our ongoing IP protection strategy. We look forward to continuing to develop our strong intellectual property portfolio position as we continue to learn more about our technology, its products and applications and progress the Hazer Process through commercial demonstration and scale-up phases.”
