

## **CLEANSING NOTICE & APPENDIX 3B**

**PERTH, AUSTRALIA; 5 DECEMBER 2019:** Please see attached an Appendix 3B in respect of the issue of 8,980,441 fully paid ordinary shares pursuant to the Share Purchase Plan (SPP) which closed oversubscribed on Friday 29 November 2019 raising approximately \$3,457,507 (please refer to ASX announcement dated 3 December 2019).
