

CLEANSING NOTICE

PERTH, AUSTRALIA; 23 NOVEMBER 2020: Hazer Group (ASX: HZR) (**Hazer** or the **Company**) provides the following information in relation to the shares issued today being:

- (i) 600,000 new fully paid ordinary shares (Shares) pursuant to the exercise of 600,000 unlisted Series B options with a \$0.40 exercise price and 31 December 2020 expiry date, raising \$240,000.

Notice pursuant to Section 708A(5)(e) of the Corporations Act 2001 (Cth) ("Act")

- 4 as at the date of this notice, there is no information to be disclosed under section 708(6)(e) of the Act which is excluded information (as defined in sections 708A(7) and 708A(8) of the Act).
